1. Selection of an Interim Manager

Mayor Sasser addresses the Commission stated that he has been speaking with the attorney for the past few days about questions from the community.

Mayor Sasser calls upon City Attorney Brandenburg to clarify.

City Attorney Brandenburg addressed the Commission and stated:

- The other evening the commission had a discussion regarding the City Manager and you were discussing his evaluation.
- At that time Mr. Brock offered his resignation effective thirty (30) days forward
- The issue has come up as to whether or not the city wants to appoint an Interim Manager to be effective immediately, and to have Mr. Brock basically serve as a consultant for the next thirty (30) days for whoever you choose to run the city during that period of time.
- Members of the community have expressed concern regarding leadership of the city with regarding a person who is in transition from a current position to a new position.

1. Selection of an Interim Manager continued:

Mayor Sasser suggests meeting with Mr. Moore regarding his input on how to proceed regarding financial as he will be doing dual duties.

Commission Appoints City Attorney Brandenburg to meet with Mr. Moore.

2. Selection process of a new City Manager

Mayor Sasser suggests tabling this item until the next Commission Meeting.


Commissioner Walker suggests allowing Mr. Moore to remain as Interim until after the budget process, could accept applications.

Item tabled until next Commission meeting.


Mayor Sasser:
