I. RESOLUTION:

RESOLUTION 2015-33 - A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA FIXING THE FINAL MILLAGE FOR THE FISCAL YEAR 2015-2016 ON ALL TAXABLE REAL AND PERSONAL PROPERTY TO PROVIDE FOR GENERAL OPERATING EXPENSES, AND DECLARING A TAX LEVY UPON SAID PROPERTY.

Motion made by Vice Mayor Walker to approve Resolution 2015-33; Seconded by Commissioner Biggs w/Comments.

Commissioner Biggs Asked where in the budget was Legal Services identified; where is the salary for the Director of Economic and Community Development; where is the salary for the HR Manager; and where is the salary for the Administrative Assistant? The Deputy City Manager advised the commissioner that those salaries are identified in each of the department budgets. She was told that the Administrative Assistant salary is included in the Finance Dept. budget.

RESULTION 2015-31 - A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, RELATING TO FINANCES, PROVIDING FOR THE ADOPTION AND FUNDING OF THE FINAL MUNICIPAL BUDGET IN THE AMOUNT OF \$3,740,556 OF THE CITY OF PAHOKEE FLORIDA, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2015, AND ENDING SEPTEMBER 30, 2016.
