Report of the City Manager:

City Manager Moore thanked Staff and acknowledged some of the donator who contributed to the Back to School Bash, such as; Back to School Bash Foundation, Senator Abruzzo, Florida Crystals, PNC, PBC Office of Community Revitalization, H. E. Hill Foundation, Sugar Cane Growers Cooperative of Florida, Wedgeworth Farms, Nova Southeastern University donated computers that were giveaways, and many more. City Manager Moore advised 37 computers, six laptops, six iPads and three Beats were giveaway at the Back to School Bash.
