Commission Meeting Agenda, February 11, 2014

Additions, Deletions, and Approval of Agenda:

City Manager Moore advised he will be deleting Employee and Director of the Quarter from Presentations and adding Marina Dockage Agreement and Campground Rental Agreement to Report of the City Attorney.

Commissioner Walker inquired as to why the City Manager will be removing the Employee and Director of the Quarter presentation.

City Manager Moore advised the proper process he established was not followed and he directed staff to redo the process.

Consent Agenda:

Resolution 2014 - 02: City Manager Moore advised at a prior Commission Meeting a representative from Shiloh Missionary Church stated a few years ago the City agreed to donate the property to the church, but the transfer was not completed.

Resolution 2014 – 03: City Manager advised the \$43,118.80 is to assist with the matching dollars for the USDA Emergency Equipment grant.

Mayor Walkes asked if the \$43,118.80 is associated with the COOP & Evacuation Grant.

City Manger Moore advised it is a separate item and he will provide a detailed list of the equipments to be purchased with USDA grant. He advised the balance from the COOP & Evacuation grants will purchase six generators, six lap tops and nine chain saws all to be shares equally amongst Pahokee, Belle Glade and South Bay. City Manager Moore advised Commissioner Babb is not feeling well and he will not be able to attend tonight's meeting.

Report of the City Manager:

City Manager Moore advised he provided an Employee Survey and a Customer Service Survey for their review and approval.

Report of the City Attorney

City Attorney Brandenburg advised he closed out the report for the termination of Wayne Gray's lease. He provided a Dockage Agreement and Campground Rental Agreement for approval at the next meeting.

Cafeteria Rental Agreement: City Manager Moore provided recommendation for changes in the agenda.
