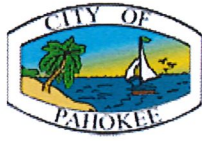

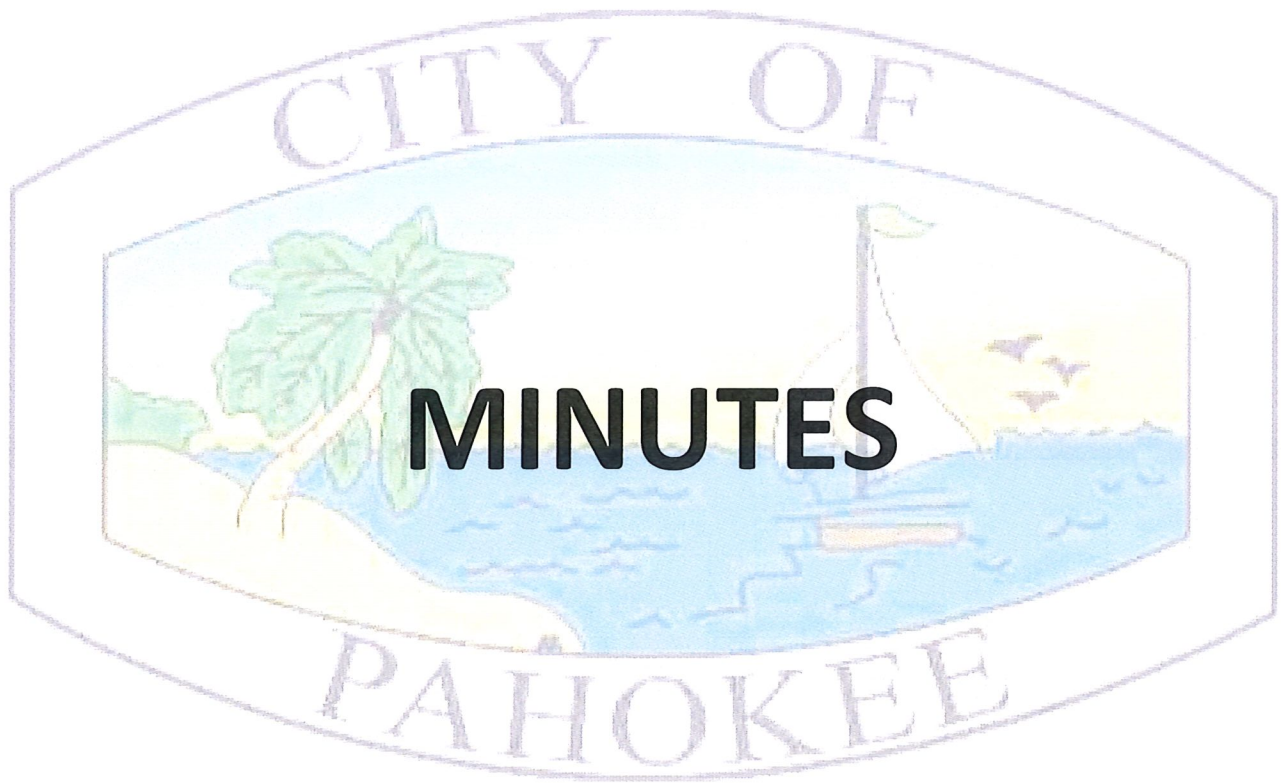

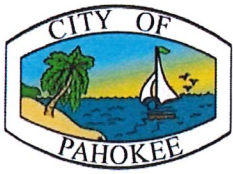

- Discussion ensued. Mr. Williamson advised there is signage posted for the truck routes.

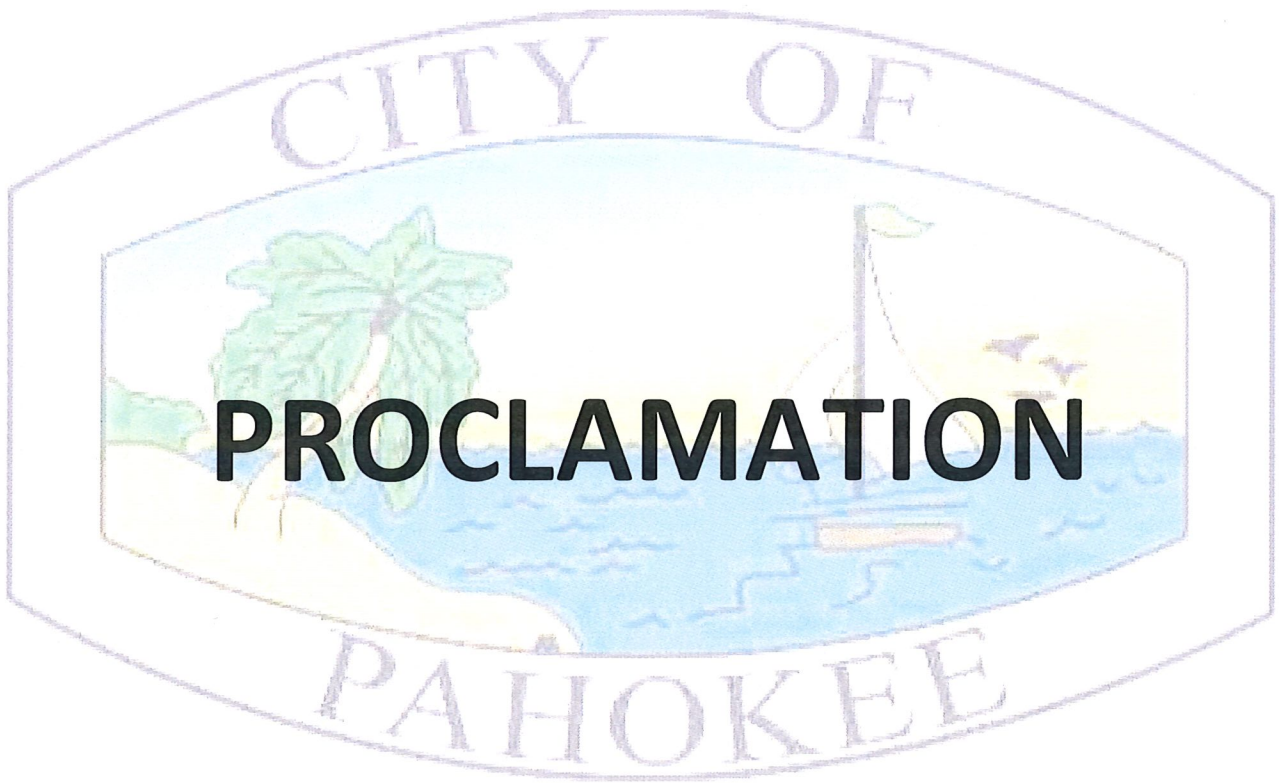
Mr. Williamson advised Ordinance 2018 – 04 can be reviewed again, as it relates to the parking of trucks within city limits.

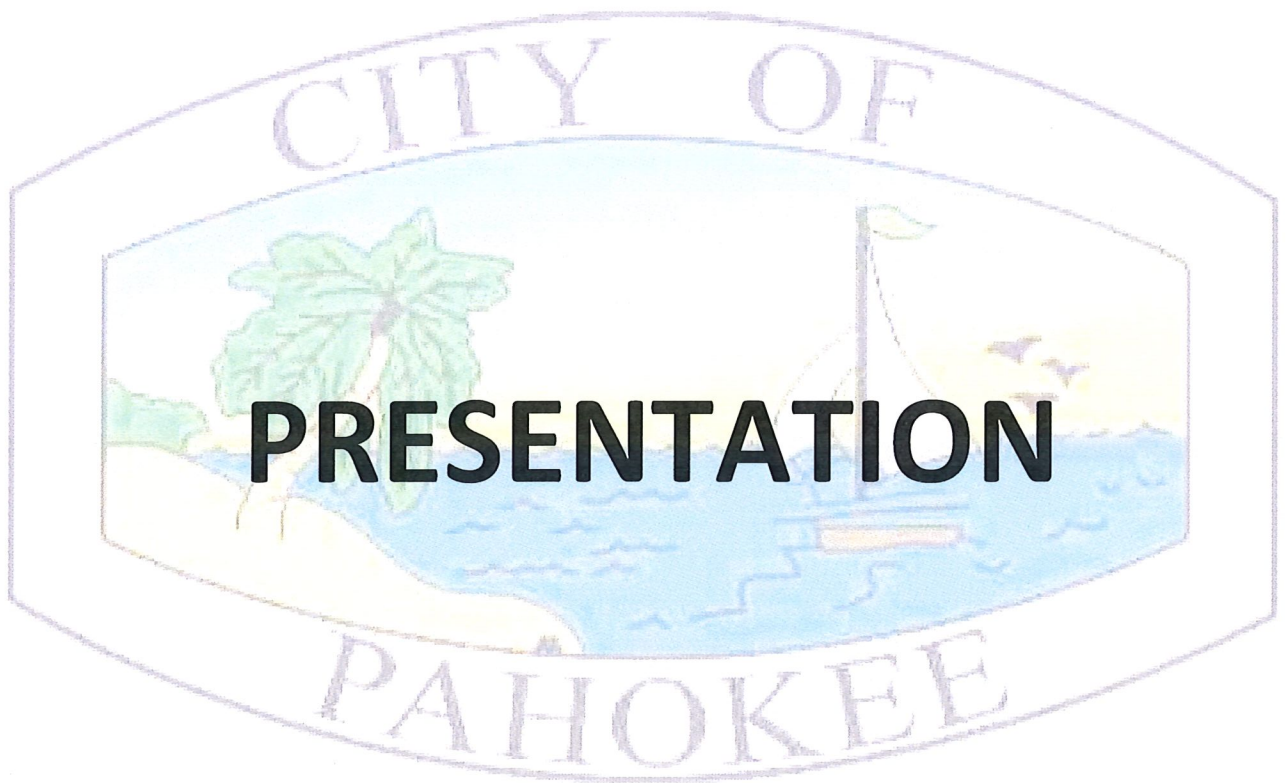

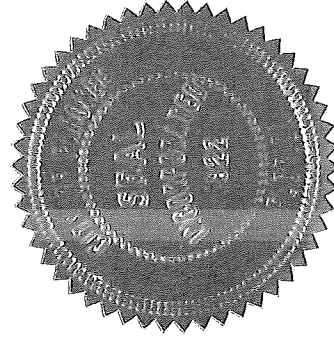
