Be advised that anyone choosing to appeal any final decision made by the BCC, with respect to any matter discussed at the hearing will need to provide their own court reporter to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based.



Summary: Proposed is a Class B Conditional Use for Universal Biocarbon. The 28.74 acre site is currently being used for Chipping and Mulching use with a Composting facility.

The Class B Conditional Use request is for Chipping and Mulching use on 2.07 acres of the 28.74 acre site. A subsequent administrative application will include a request for a Composting use on 7.23 acres within the overall site. A total of 24 parking spaces will be provided, 2 more than the minimum required 22 spaces. Access to the site is from Guava Lane and Old Connors Highway.
